Results of accident investigation released


The City of Liberty is releasing the following information regarding an incident that occurred in the middle of the night on November 20, 2025.

In the middle of the night on November 20, 2025, a City of Liberty Police Department officer was involved in an automobilepedestrian accident during the course of duty. Preliminary information indicates that the officer accidentally struck a pedestrian with the side-view mirror of his vehicle. Emergency medical personnel responded immediately and the pedestrian received prompt medical care.

In the interest of transparency and to ensure a fully independent review, the City of Liberty requested the Texas Department of Public Safety (DPS) to conduct the investigation into the crash. DPS investigators responded to the scene and completed their review of the incident.

Based on the findings of the DPS investigation, the city has taken appropriate disciplinary action in accordance with departmental policies and applicable law. Due to personnel-privacy requirements, the city is limited in the amount of detail that can be released; however, we want to reassure the community that the matter has been handled with the seriousness it deserves.

The City of Liberty remains committed to accountability, public safety, and maintaining the trust of our residents. We thank DPS for its professional and impartial investigation.
