DAYTON SENIORS DISCOUNT UTILITY RATES

DAYTON - The City of Dayton is offering senior residents, age 65 and over, a 20 percent discount on their water and sewer bills. To receive the discount, seniors must provide their driver's license and either proof of homestead exemption or a current lease agreement in their name. The documents can be brought to the city office at 117 Cook Street. Seniors are limited to using this discount on one account. Landlord accounts and trash services do not qualify for this discount.
