### PUBLIC NOTICE

On June 26, 2026, Entergy Texas, Inc. ("ETI") filed an application with the Public Utility Commission of Texas ("Commission" or "PUC") requesting approval of a power purchase agreement ("Long-Term Frontier PPA") pursuant to Public Utility Regulatory Act ("PURA") §§ 36.205(e) and 39.452(j). As part of its long-term electric supply resource plan, ETI has determined that it needs additional generating resources in the near future. The PPA with Tenaska Frontier Partners, Ltd ("Tenaska") for the purchase of generation capacity from the Tenaska Frontier Generating Station ("Frontier Station") is intended to address a portion of the resource need. The docket number and style of the application are PUC Docket No. 59928, Application of Entergy Texas, Inc. for Approval of Frontier Power Purchase Agreement. ETI is not seeking to change its rates in this proceeding.

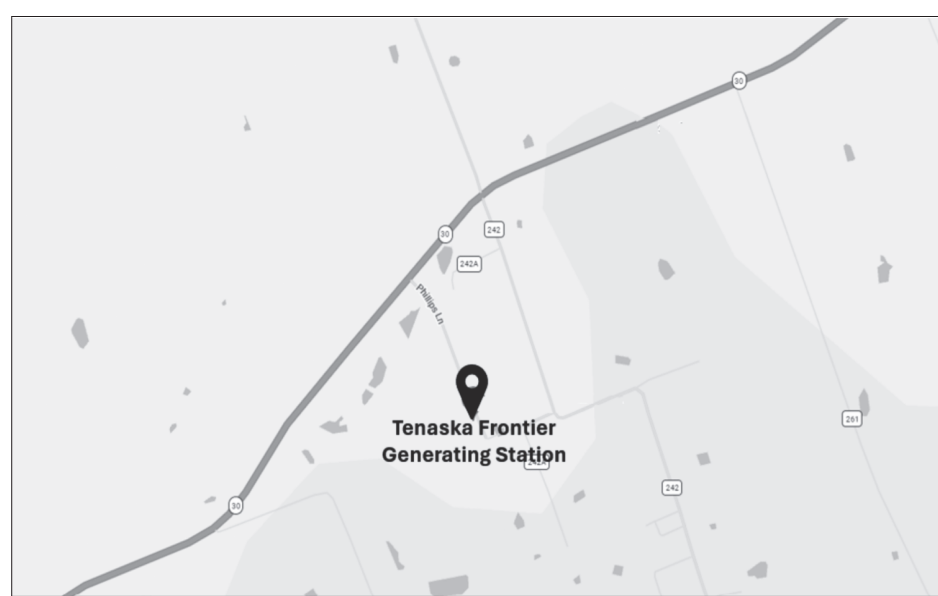
The Application seeks approval of the Long-Term Frontier PPA for the purchase of 300 megawatts ("MW") of generation capacity from Frontier Station, an 830 MW natural-gas fired combined-cycle combustion turbine plant located in Grimes County, Texas, at 17500 Highway ("Hwy") 30 in Shiro. The plant is situated approximately 1.5 miles east of the State Hwy 90 intersection. The Long-Term Frontier PPA will provide dispatchable power beginning on June 1, 2027, and continue for 14 years. ETI expects that the cumulative cost of the Long-Term Frontier PPA will be roughly \$883 million over its 14-year term. ETI has no obligation to purchase power under the Frontier PPA unless it is approved by the Commission.

ETI has requested a deadline for intervention in this proceeding of July 27, 2026, and a letter requesting intervention should be received by the Commission by that date. A request to intervene (original and ten copies) or request for further information should be mailed in to the Public Utility Commission of Texas, P.O. Box 13326, Austin, Texas 78711-3326. Persons who wish to intervene in or comment upon these proceedings should notify the Public Utility Commission of Texas as soon as possible, as an intervention deadline will be imposed.

The preferred method for you to file your request for intervention is electronically, and you will be required to serve the request on other parties by email. Therefore, please include your own email address on the intervention request.
