Dr. David Arnold and his lovely bride Connie came to the GOP Candidate Meet & Greet last week to show their support for family member Kim Harris.



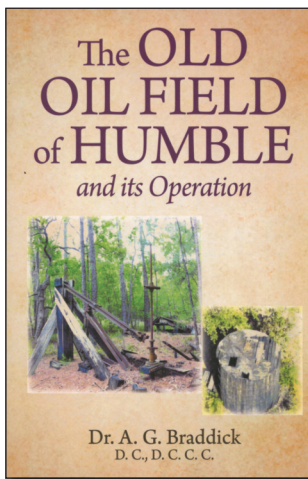
